**IMMEDIATE NOTIFICATION UNDER ARTICLE 12.5 OF THE AGREEMENT  
ON SAFEGUARDS TO THE COUNCIL FOR TRADE IN GOODS OF  
PROPOSED SUSPENSION OF CONCESSIONS AND OTHER  
OBLIGATIONS REFERRED TO IN PARAGRAPH 2  
OF ARTICLE 8 OF THE AGREEMENT  
ON SAFEGUARDS**

TURKEY

The following communication, dated 21 May 2018, is being circulated at the request of the Delegation of Turkey.

Pursuant to Article 12.5 of the Agreement on Safeguards, and in accordance with the agreed format for notifications (G/SG/1, 1 July 1996), the Government of Turkey provides the immediate notification to the Council for Trade in Goods of proposed suspension of concessions and other obligations referred to in paragraph 2 of Article 8.

**1. Which Member is proposing suspension of concessions and other obligations referred to in Article 8.2?**

Turkey.

**2. Specify the measure, the product subject to the measure, the WTO document that notified the safeguard measure, and the Member imposing the measure in relation to which the Member is proposing suspension of concessions and other obligations referred to in Article 8.2**

The applied measures taken by the United States on imports of steel and aluminum from 23 March 2018.

In response to Turkey's consultations request (G/SG/183 dated 20 April 2018) with regard to the above-mentioned measures, the United States stated that "these actions are not safeguard measures, and therefore, there is no basis to conduct consultations under the Agreement on Safeguards with respect to these measures." However, Turkey still considers them as safeguard measures which are not consistent with the provisions of the Safeguard Agreement.

**3. Describe the proposed suspension of concessions and other obligations referred to in Article 8.2, and the proposed date from which it will come into effect**

The proposed suspension of substantially equivalent concessions and other obligations under GATT 1994 to the trade of the United States takes the form of an increase in tariffs on selected products originating in the United States (as indicated in Annex I and calculated as indicated in Annex II). Turkey reserves its right to further suspend substantially equivalent concessions and other obligations based on the rest part of the measures of the United States.

Without prejudice to the effective exercise of its right to suspend substantially equivalent concessions or other obligations referred to in Article 8.2, the Government of Turkey reserves its right to effectuate the proposed suspension from 21 June 2018 and adjust the products as well as the tariff rates.
